To check the status of a refund, call TeleTax at 1-800-829-4477 (toll free) or go to [www.irs.gov](http://www.irs.gov) and click on "Where's My Refund."

\* The IRS does not guarantee a specific date that a refund will be deposited into a taxpayer's financial institution account or mailed.
